* Assessments - For Contractors Only. In addition to the yearly chapter dues of \$1,000, the established contractor will be billed \$1.10 per thousand dollars of assessable concrete pavement work to a maximum assessment of \$15,000/year. (approximately \$13.6M of assessable work). The contractor chapter dues plus assessments are capped at a maximum of \$16,000/year. For new contractor members, first year assessments will be a maximum of \$5000.

Assessable concrete pavement work includes, Highway Pavements, Airport Pavements, Streets & Roads, Parking Areas, Pervious Paving, Full & Partial Depth Patching, Slab Stabilization, Grinding & Grooving, Joint & Crack Sawing & Sealing, Retrofitting Dowel Bars & Tie Bars, Cement Stabilized Bases, Lean Concrete Bases, Shoulders, and Barriers.
